As per our bylaws a Special General Meeting can be called at anytime provided the requirements are met as listed.

3.2 Special Meeting – A Special Meeting of the Members may be called at any time by Ordinary Resolution of the Board or upon the written requisition of ten percent (10%) or more of the Members for any purpose connected with the affairs of the Corporation that does not fall within the exceptions listed in the Act or is otherwise inconsistent with the Act, within twenty-one (21) days from the date of the deposit of the requisition.

Attached is the request for a Special General Meeting signed by 5 members that are in good standing. Please read and review the documents.

This SGM will be held Saturday October 30, 1pm at the Scarborough Soccer Centre (45 Fairfax Cres.) Doors will be open at 12:30pm. Although only member clubs with teams that participated in 2021 can vote on the resolutions, this meeting is open to all Central Region Clubs/Academies.

COVID protocols will be in effect which include masks to be worn at all times (except when addressing the meeting). Proof of double vaccination (Completed 14 days prior) must be shown at the door along with a contact tracing form to be filled out. The meeting will be held on one of the indoor fields in which chairs will be placed to ensure social distancing.
